Terms of Enrollment

1. The camp registration form and deposit reservation must be paid by the agreed upon period.
Please note: RNH is closed on JULY 4th
2. Registration forms must be returned by **March 14, 2014** with a non-refundable \$300.00 deposit.
3. Camp is in session from June 30th – August 22nd, 2014 from 8:00AM– 4:00 PM. After camp care fees apply after 4:00 PM (please see registration form). **LATE FEES of \$25.00 will be imposed if children are not picked up by agreed upon time. (There is limited availability for care from 5:00 – 6:00 PM for an additional \$60.00/week per child.)**
4. All children must arrive no later than 9:00AM.
5. You are required to enroll your child for a minimum of four (4) consecutive weeks. (E.g. June 30th- July 25th, July 28th – august 22nd or June 30th – August 22nd).
6. Please note that days/weeks cannot be substituted and/or refunded for family vacation, illness, or any other reason. Deposits are non-refundable.
7. **Half (½) of your total camp payment must be submitted by Friday, April 25th**
8. The **remaining** balance of your camp payment must be submitted by **Monday, June 2nd**.
9. Please note that the NYC Dept. of Education has eliminated the summer lunch program for community based camps and, therefore, campers must bring their lunch (except on BBQ Wednesdays).**No Peanut Butter.**
10. MEDICAL FORMS: **A medical form, which will be provided to you, must be submitted by June 2nd.** Department of Health regulations mandate that no child can attend camp without an up-to-date medical form on file. **If you are enrolling your child (ren) for Session 2, medicals must be in our file by July 1st.** FAILURE TO HAND IN A MEDICAL WILL RESULT IN DELAYED START DATES. MEDICALS WILL NOT BE ACCEPTED ON THE FIRST DAY OF CAMP.
11. In the event of an emergency, parents will be called first, and then we will call emergency contact. It is your responsibility to maintain all contact information up to date.
12. Fees include all costs for transportation, admission, swimming, sports activities, daily and special activities and a light breakfast and daily snack.
