Terms of Enrollment

1. The camp registration form and deposit reservation must be paid by the agreed upon period.
2. **Registration forms must be returned on or before 3/9/18, with a non-refundable \$300.00 deposit plus \$50.00 non- refundable registration fee.** (Deposit is subtracted from total but not registration fee)
3. Camp is in session from July 2nd– August 17th, 2018 from 8:00AM– 4:00 PM. After camp care fees apply after 4:00 PM (please see registration form). **LATE FEES of \$25.00 will be imposed if children are not picked up by agreed upon time.** (*There is limited availability for care from 5:00 – 6:00 PM for an additional fee.*)
4. All children must arrive no later than 9:00AM with bathing suits under clothing.
5. You are required to enroll your child for a minimum of four (4) consecutive weeks. (ex.. July 2nd - July 27th).
6. Please note that days/weeks cannot be substituted and/or refunded for family vacation, illness, or any other reason. **Deposits are non-refundable.**
7. **Half (½) of your total camp payment minus your deposit must be submitted by Friday May 4th . (Non-Refundable).**
8. The **remaining** balance of your camp payment must be submitted by **Friday, June 1st (Non-Refundable).**
9. Please note that the NYC Dept. of Education has eliminated the summer lunch program for community based camps and, therefore, campers must bring their lunch cold or in a thermos- No Microwave (we have a BBQ on Wednesdays). **No Nut products of any type.**
10. **MEDICAL FORMS: A medical form, which will be provided to you, must be submitted by June 1st. A PPD (TB) shot must be addressed by the Doctor.** Department of Health regulations mandates that no child can attend camp without an up-to-date medical form on file. **If you are enrolling your child(ren) for Session 2, medicals must be in our file by July 2nd. MEDICALS WILL NOT BE ACCEPTED ON THE FIRST DAY OF CAMP.**
11. In the event of an emergency, parents will be called first, then we will call emergency contact. It is your responsibility to maintain all contact information up to date.
12. Fees include all costs for transportation, admission, swimming, sports activities, daily and special activities and a light breakfast and daily snack.
